#### **Financial Summary**

#### **Quarterly Commentary**

Q2 cash receipts were impacted by Christmas resulting in delays with payment of customer invoices. This was reflected in the substantial increase in group debtors compared to the end of Q1 (unaudited Q2 Trade Debtors were \$245,164 versus unaudited Q1 Trade Debtors of \$135,146).

Importantly, the Company accelerated investment in preparing its spatial data sets and Geographic Notification and Information System (GNIS) to engage with Australia's largest GIS data distribution channel, Esri. While this has contributed to a deficit for the quarter, the work is complete with data flowing into the national network and community of GIS professionals.

### **EWN Partnership Update**

Following commentary on the Company's strategy to scale and our recent announcement regarding the partnership with Esri, we are pleased to confirm that EWN's real-time risk data is now ready to 'live stream' into the Esri network of GIS users.

This implementation is the final stage in the Company's strategy to scale. It includes a new agreement that is currently being negotiated with the region's leading end-to-end data solutions company.

The roll-out follows extensive development and testing in the previous quarter and is already in trial with numerous customers. The next step includes an aggressive sales and marketing effort which will directly inform thousands of users that access to the data is now available. Users include mostly large businesses together with federal, state and local government agencies.

This will be supported by a national network of business development managers and support staff which covers multiple industry verticals and regions.



Following six months of effort by EWN and its new data distribution partner, the Company has now established an operational, friction free channel, specifically designed to scale the business.
